To see if the Village District will vote to raise and appropriate the sum of \$100,615 for purchase of a Dodge 5500 and to authorize the issuance of not more than \$85,615 of bonds or notes in accordance with the provisions of the Municipal Finance Act (RSA 33) and to authorize the municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon; to appropriate \$15,000 from the Highway Equipment Capital Reserve Fund and further, to raise and appropriate the amount of \$19,000 for the first year's payment.
