The primary purpose of this meeting was a final review and update of the Asset Management Plan Report by Horizons Engineering with a focus on the Capital Improvement Plan in preparation for the Commissioners review on Friday, 5/27.

- JB -- Water Committee will meet with Commissioner Ralph Lutjen on Friday, 5/27, 7:30am.
 We have the letter from Ralph expressing his concerns & issues with the DRAFT Report
- LL -- Need to expand the 5-year Capital Improvements Plan to a 10-year Plan to spread the costs out
- CC -- Pipe Replacement Cost: seeing a 30% increase from 2021 to 2022
 -- 6" Main is about \$250/LF including service connections & gate valves
- JB -- A priority should be Interlaken Circle / Big Loop: about 1,100'
 - -- Should be 8" to complete the around-the-lakes loop
- CC -- Will remove OSHA references from pump houses can work on that later
 - -- Table 4.1 will remove the last column at the right (it is erroneous)
- LL -- Table 4.1 Risk Level 4 is overwhelming "Immediate Attention"
- LS -- Need to be clear that this AMP is only a start the work needs to be ongoing
- DP -- The updates from Ian's map work and the maps sent by Jay: integrated?
- CC -- Yes this has been done
- DP -- Appendix J Customers by Zone is this accurate?
- CC -- Horizons is updating this from Ian's drawings of zones on the maps
- LL -- Addition of meters on zones?
- CC -- This is included in the Operational Recommendations
- DP -- Table 7.1 number of customers is flat across future years
- CC -- Will adjust this to increase the number of customers by 10 per year
- DP -- Pump house data charts up-to-date?
- CC -- Yes these have been updated
- DP -- Table on pgs. 2-3 does not match Table 8.1
- CC -- Will update this
- CC -- Will complete all updates and send an updated report tomorrow (Thursday) for the Commissioners review on Friday
- CC -- If approved by the Commissioners, will wrap up enough for submission to DES on 5/31

- JB -- Maps When final, the Water Committee requests printed copies of maps from Horizons as follows:
 - -- Water line map for the Water Operator
 - -- Street map for the VDOE Office
 - -- Extra street map for the Madison Fire Department
