Tuesday, June 18, 2024

The Board of Commissioners met at 9:00am on June 18, 2024. In attendance for the public meeting are Commissioner Mark Graffam, Commissioner Wooda McNiven, Commissioner Nancy Cole, Administrator Jennifer Scully, DPW – Jeff DeMartino and Treasurer Dinah Reiss.

Public Meeting

At 9:00am Commissioner Mark Graffam calls the meeting to order.

- 1. <u>Approval of Agenda</u> Mark Graffam makes a motion to approve the June 11, 2024, Agenda to recess at the section of Correspondence for a Non-Public Session which will also recess and continue Wednesday, June 19, 2024, at 10:00am. Motion is 2nd by Nancy and the motion is passed 3-0-0.
- 2. <u>Approval of Minutes</u> Mark Graffam makes a motion to approve the Commissioners Meeting Minutes of June 4, 2024. Nancy 2nds the motion. For discussion Wooda McNiven adds he request additional time fully read the minutes. The motion passes 2-0-1 for the June 4th meeting minutes.

Mark Graffam makes a motion to approve the Commissioners Meeting Minutes of June 11, 2024. Nancy 2nds the motion. Mark adds that a correction to the minutes be made on page 2 of 4. The motion is passed, with amendments, 3-0-0.

3. Approval of Manifest

- 1. Operations Manifest totaling \$5,070.83. Mark makes motion to approve. Nancy 2nds the motion. Mark adds that an additional check be created and submitted for this manifest adding \$12,480.00 to pay for the services provided by Kevin O'Leary, PLLC. Updated Operations Manifest now totals \$\$17,550.83. The motion to approve the updated Operations Manifest amount is passed 3-0-0.
- 2. Water Manifest totaling \$6,183.24. Mark makes motion to approve. Nancy 2nds and the motion is passed 3-0-0.

4. DPW @ 9:13am Jeff DeMartino

- Rafts have been put in the water.
- Painting of the white lines has begun but notes that Grison Rd cannot be done. The
 condition of this area of road is very bad due to an ongoing drainage issue that must be
 addressed first. Hot Top would be used to repair this. Mark Graffam makes a motion to



purchase 2 tons of Hot Top, not to exceed \$200.00 total. Also to include the rental of a roller for best application. Nancy 2nds and the motion is passed 3-0-0.

- DPW to review roadway in vicinity of 22 Aspen as a section needs to be addressed to minimize additional erosion.
- The toy excavator at the playground has had the seat fixed and is ready for use again.
- Jeff continues to work on the culvert data required by FEMA. Jeff will come to the office to review data submitted by Doug Prescott.
- Summary of ditching work that needs to be done this year has been submitted to FEMA for review.
- Pipe repairs/replacement on Dorfli Road and 9 Adelboden Way needs to be done. Mark Graffam makes a motion to purchase 3 20 by 18" plastic culvert pipes. Nancy 2nds the motion and the motion is passed 3-0-0.
- The pipe on Grison Rd is metal and is currently bent and does not allow for proper flow and debris has built up. Jeff will investigate possibly cutting damaged area of pipe to allow better flow.
- Speed bumps are scheduled to be installed early morning on Thursday.
- Mark Graffam makes a motion to purchase 3 aluminum signs with intent to place on trees at Big Loop, Presidential View and Oak Ridge. Nancy 2nds and the motion is passed 3-0-0.
- Commissioners need to review Appenvel gravel roadway and the areas that are consistently being repaired due to the steep levels of its driveways.

5. Administrator's Report @ 9:47am

- a. The Posting for the Dam Inspection meeting will be done. Meeting to occur June 27th at 10am.
- **b.** CCR (Consumer Confidence Report) requires additional review and a few questions have been proposed to complete any modification. Further review will be done, and this issue will continue to be discussed on Wednesday, June 19th.
- c. Muddy Beach #2 Well Pump is not functioning and according to Ian at Simply Water samples direct from this well cannot be done until the pump is fixed. Usage reading has been showing 0 for both wells and additional clarification is needed from the water operator as to the purpose of testing from these wells when we show no usage. Mark Graffam makes a motion to contact the water operator company Simply Water, to obtain codes for the office to access the pump houses. This will allow review of the logbooks and systems. Nancy 2nds and the motion is passed 3-0-0.

 Grachen Dr. and 9 Winnegon. Mark Graffam makes a motion to approve these
 three work order requests. Nancy 2nds and the motion is passed 3-0-0.
 Inquiry to validate a "lottery won" water hook up at 12 Jungfrau will need
 further investigation.
- e. Mark Graffam makes a motion to run the DPW help wanted ad, designed and reviewed, through Conway Daily Sun, web site and the Facebook page. Nancy 2nds the motion and the motion is passed 3-0-0.
- f. No status of credit card application through Norway Savings Bank.

6. Commissioner's Concerns/Reports @ 10:27am

Mark Graffam

- Mark Graffam makes a motion to open another checking account through Northway Savings Bank for the purpose of migrating the Operations Account from Bank of New Hampshire. \$40,000.00 from current Operating Account will be the first deposit for this account. Nancy 2nds and the motion is passed 3-0-0.
- Nancy proposes the option to open another bank account at Northway for the purpose of transferring "Water Hook-up" payments from the Assessment account to its own account.

Nancy 2nds and the motion is passed 3-0-0.


7. <u>Correspondence</u> @ 11:47am
