Public Meeting

Mark Graffam

- Mark provided information of his knowledge of Backflow Prevention Devices and how important it is to understand that if a water connection is further extended at a property, for such purposes as water access to a detached garage, and there has been no backflow prevention devise installed, this connection will have the potential of contamination back into the water system.
- Discussion to reach out to contacts that have knowledge of Eidelweiss's Water System and could provide specific information and possible data from prior system record keeping, previously used by the VDOA.

Wooda McNiven

- Wooda will try and have the vendor submit his invoicing for work completed at the Cabana. Nancy Cole reminds that this invoice payment must be coded to the Warrant Article.
- Wooda has given the DPW job description to the potential person who may have interest. He has asked that an application &/or resume be submitted to the office if this potential has an interest.
