Public Meeting

At 10:00am Commissioner Mark Graffam calls the meeting to order and asks the attendees how long this special meeting should go before adjourning. The consensus was one hour of discussions.

1. Approval of Agenda

Mark Graffam asks the attendees to list and prioritize their subjects of interest for discussion at 10:02 am. The list was completed and prioritized by 10:13 am.

The pre-prioritized list:

- 2) The Pond Level Management Ordinance (The Dam on Little Pea)
- 3) Use of Volunteers
- 4) The Water System
- 5) Roads and Culverts
- 6) Beach Public Outhouses
- 7) Renting VDOE Garage Space for Revenue
- 8) Timber Sale for Revenue
- 9) Madison 's Eidelweiss District Zoning Ordinances -Camping etc.
- 10) Recreation Facilities Boat Racks Playground Boat Racks Beaches Parking Lighting etc.
- 11) Information Technology Support

2. The Prioritized Discussions started at 10:13 am

1) Tax Planning – 10:13 am to 10:47 am - There was a review of the short time period for planning the 2024 Budget and two newly appointed Commissioners in February of 2024. The next Special Meeting, in November or the beginning of December, will focus only on the 2025 Budget. Inflation, legal expenditures, possible FEMA reimbursements, loans, roads, and water system issues were discussed. Managing a tax rate that doesn't spike up and down was discussed.

- 2) **Beach and recreation Facility Issues** 10:47 am to 11:17 am The first issue discussed was renting blue plastic Porta Potties verses fixing the problem with the brown board and batten outhouses. All the Attendees were in favor of fixing the old outhouses. Trash dumping, lighting, controlling and restricting parking, cameras, the playground equipment and clean-up and boat racks were discussed. Thomas Gunn, Mindy Prescott, and Jennifer Nolan expressed interest in providing continuing feedback to the Board, as a Special Interest Group on Beach and Rec Facility Issues.
- Madison Zoning Ordinances 11:17 am to 11:35 Camping, "Off Grid" Housing, "Tiny Houses" and the procedures for changing the Eidelweiss Residential Zone Regulations within the Madison Zoning Ordinances were discussed.

A short discussion on Volunteers followed.
